ISSUE OF UP TO S\$100,000,000 IN AGGREGATE PRINCIPAL AMOUNT OF 2.5% REDEEMABLE CONVERTIBLE BONDS DUE 2018

- ISSUE OF 176,470,588 CONVERSION SHARES

Unless otherwise defined herein or the context otherwise requires, all capitalised terms herein shall bear the same meanings as ascribed to them in the Company's circular to Shareholders dated 5 April 2016.

1. The board of directors (the "**Board**") of LionGold Corp Ltd (the "**Company**") refers to the announcements of the Company dated 20 June 2015, 12 August 2015, 17 September 2015, 5 April 2016 and 4 October 2016 in relation to the issue of 2.5% redeemable convertible bonds due 2018 in the aggregate principal amount of up to S\$100,000,000 and wishes to announce that the Subscriber has on 20 January 2017 exercised its right to convert three (3) RCBs (Certificate Number: N0137 to N0139) with an aggregate principal value of S\$150,000 in accordance with the terms and conditions of the subscription agreement dated 19 June 2015 (as amended by the supplemental agreements dated 5 April 2016 and 4 October 2016). The three (3) RCBs will be converted into 176,470,588 Conversion Shares at the Conversion Price of S\$0.00085 per Conversion Share.
2. The Conversion Price of S\$0.00085 was determined by taking 85% of the average of the traded volume weighted average price per Share for any three (3) consecutive Trading Days determined at the sole and absolute discretion of the Bondholder, during the 30 Trading Days immediately preceding the relevant Conversion Date, being 20 January 2017. The three (3) consecutive Trading Days and their average of the traded volume weighted average price per Share are as follows:

Date	Volume Weighted Average Price
22 December 2016	S\$0.0010 (" X ")
27 December 2016	S\$0.0010 (" Y ")
28 December 2016	S\$0.0010 (" Z ")

3. As such, the Conversion Price is determined by the following calculation:

$$\text{Conversion Price} = \frac{X + Y + Z}{3} \times 0.85 = \text{S\$0.00085}$$

4. The Conversion Shares shall be issued free from all claims, charges, liens and other encumbrances whatsoever and shall rank *pari passu* in all respects with and carry all rights similar to existing Shares, except that the Conversion Shares will not be entitled to any dividends, rights, allotments or other distributions, the Record Date for which falls before the date of allotment and issue of the Conversion Shares. Following the allotment and issuance of the Conversion Shares on 20 January 2017, the issued and paid-up share capital of the Company has increased from 4,992,278,771 Shares to 5,168,749,359 Shares.
5. The Conversion Shares are expected to be listed and quoted on Catalist with effect from 9.00 a.m. on or about 24 January 2017.
